Manufacturing Member

Annual Dues are calculated based on annual revenues. Revenues are defined as all revenues a company derives from the business activities of collective operations in North America, including all goods and services accounted from North America corporate profit centers that result in being sited inside or outside North America.

After the first year of membership, dues are \$2,500 plus .0002 times those revenues over \$3,000,000 (\$200 per million), but not exceeding \$7,900 per year.

After the first year of membership, annual dues are \$3,000.
